

## The Paper and Hearts Society Pre-order Giveaway Offer

Proof of pre-order purchase can include an ereceipt, order number, screen shot of order confirmation or a scanned copy of a physical receipt.
- 2) The Offer opens at 9:00am BST on Friday 5<sup>th</sup> April 2019 and closes at 11:59pm BST on Wednesday 12<sup>th</sup> June 2019. Any entries received outside these specified times and dates will not be eligible for entry into the Offer.
