

Oi Aardvark! Pre-Order Prize Draw
Terms & Conditions

Proof of pre-order purchase can include an e-receipt, order number, screen shot of order confirmation or a scanned copy of a physical receipt.
- 2) A member of the Hachette UK team will select all completed entries. No correspondence will be entered into in respect of the selected winner.
- 3) There is no purchase necessary to enter.
- 4) The prize draw opens at 8am BST on Wednesday 3rd June 2020 and **closes at 11:59pm BST on Wednesday 2nd September 2020.** Any entries received outside these specified times and dates will not be eligible for entry into the competition.
- 5) The winners will receive their prize in the post. We cannot guarantee a delivery time.
